## I UNDERSTAND THAT:

- 1. Hand-held Launchers and Bird Banger, Screamer Siren, Bird Banger EXP, and CAPA cartridges are for use in bird and wildlife control **ONLY**.
- 2. Instructions for proper use are furnished with each product.
- 3. In those instructions, Reed-Joseph International Company recommends the use of ear and eye protection when using all pyrotechnics. Protection devices are available through Reed-Joseph International Company.
- 4. All pyrotechnics should be stored to prevent access by children or unauthorized persons, and they should be stored in a cool, dry, non-residential location. Pyrotechnics should be stored in original packaging, and inside a locked metal container with a non-sparking interior. Pyrotechnic storage containers are available through Reed-Joseph International Company.
- 5. Reed-Joseph International Company shall not be held responsible for any injury resulting from the use or handling of these devices whether or not used in accordance with directions.
- 6. The buyer agrees to secure Federal, State and local permits as required.
- 7. The buyer of explosive products must be twenty-one (21) years of age or older.
- 8. The buyer hereby accepts said material subject to all terms hereof.

Please be advised that all Reed-Joseph International Company sales records for pyrotechnics and related shipping documents are available to, and are subject to examination and review by the Bureau of Alcohol, Tobacco, Firearms and Explosives - U.S. Department of Justice, and the U.S. Department of Transportation.

I hereby certify that I have a bona fide bird and/or wildlife control use for these pyrotechnic devices and certify that they will be used **ONLY** for bird and wildlife control purposes. I further understand that any other use of these items is **STRICTLY PROHIBITED BY LAW**.
